Terms and Conditions

- *By entering the draw (“the Draw”) you are agreeing to these terms and conditions.*
- *The Draw is operated by Mercy Ministries UK of Cragg Royd, Lowertown, Oxenhope, Keighley BD22 9JE (“the Promoter”).*

Eligibility to enter
